

# Muscatine County General Election

Election to be held: November 3, 2020

Polls open: 7:00 A.M.

Polls close: 9:00 P.M.

## Candidate Filing Period: **CHANGES IN FILING DEADLINES HAVE MOVED TO MARCH**

### State & Federal Offices (Nominated by Petition Candidates):

**Filing Dates: February 24 – March 13, 2020**

Nomination papers for state and federal offices must be filed with the Secretary of State in Des Moines.

### County Offices (Nominated by Petition Candidates):

**Filing Dates: March 2 – March 20, 2020**

Nomination Papers for county offices must be filed with the County Auditor.

Number of Signatures: A minimum of 250 signatures is required.

Positions include: County Auditor, County Sheriff and Board of Supervisors (District 3 and 4)

### Local Offices (Soil & Water Commissioners and Township Offices):

**Filing Dates: March 2 – March 20, 2020**

Nomination Papers for local offices must be filed with the County Auditor.

Positions and Signatures: Soil and Water Conservation Commissioner – A minimum of 25 signatures required.

Township Clerk or Trustee – no signatures required (Affidavit Only)

### Local Offices (Ag Extension Councilmember ONLY):

**Filing Date: No Start Date – August 26, 2020**

Nomination Papers for local offices must be filed with the County Auditor.

Positions and Signatures: Agricultural Extension Councilmember – A minimum of 25 signatures required.

**ALL Iowa voters are required to show a valid photo at the polls before they vote.** A voter without one of the forms of ID listed below may have the voter's identity attested to by another registered voter in the precinct or may prove identity and residence using Election Day Registration documents. Voters without the necessary ID or an attester will be offered a provisional ballot and can provide ID up until the time of the county canvass of votes.

### Acceptable Forms of Identification:

(The identification must include a photo and an expiration date.)

- Iowa Driver's License
- Iowa Non-Operator's ID
- United States Passport
- United States Military ID or Veterans ID
- Tribal ID Card/Document
- Iowa Voter Identification Card (Must have signature and PIN #)

(This is not the same as an Iowa Voter Acknowledgment Card. Only voters who have not been issued an Iowa Drivers License by the IDOT will have an Iowa Voter Identification Card.)

If you are not registered to vote and your photo ID does not contain your current address in the precinct, you are required to present one of the following documents that includes your name and current address in the precinct.

- Residential lease
- Utility bill
- Paycheck
- Property tax statement
- Bank statement
- Government issued check
- Other governmental issued document

### Voter With No Identification

Voters with no identification may establish identity and residence in the precinct by written oath of a person who is registered to vote in the same precinct.
